## **Omni Lawton Grand Opening Raffle Rules**

By entering the Raffle, you accept and agree to be bound by these Official Rules.

- 1. No Purchase Necessary: <u>No purchase or payment necessary to enter. A purchase or payment will not increase your chances of winning. Void where prohibited by law.</u>
