How does CashRepublic Financial LLC protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We authorize our employees to get your information only when they need to do their work, and we require companies that work for us to protect your information.</p>

<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <b><i>Omni Financial of Nevada Inc.</i></b></li> </ul> <p>Omni Financial of Nevada, Inc. provides a separate privacy notice for its lending products. Information related to deposit accounts and associated debit card features is not shared with Omni Financial of Nevada, Inc. except as permitted by law and necessary to service the customer relationship.</p>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <b><i>CashRepublic Financial LLC. does not share with non-affiliates.</i></b></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ <b><i>CashRepublic Financial LLC. does not jointly market with nonaffiliated financial companies.</i></b></li> </ul>
